## “OVERCOMING THE CRISIS OF DEMOCRATIC VALUES IN THE EUROPEAN UNION”

Deadline for individual paper proposal submissions: **OPEN until 31<sup>st</sup> of May 2024**

***ATTENTION: The Congress will be held entirely in English, as well as the communications.***

In recent years we have witnessed a democratic backsliding that has affected every area of our societies. Since before the crisis of refugees in 2015, the European Union has been immersed in a process of enlargement with third countries rather than deepening in its core values and policies. The rise of populisms, the attacks to journalists, and to the judiciary are only some of the visible aspects of a complex process of dismantling the rule of law, a core value of the European Union as established in article 2 of the Treaty of the EU.

The EU is aware of the urgent action that is needed to save our institutions and values and is trying to monitor the rule of law through the annual reports on each member state. However, while many are talking about the enormous problems that are affecting our rule of law and therefore our democracy, not so many are trying to focus on solutions or proposing ways of overcoming the crisis of democratic values in the European Union.

Is in this spirit that this Congress is held. We seek to explore the interplay between the European Union values and their reflection in society, how they are (de)constructed and its implications for our democracies. The rule of law is a concept intertwined with democracy and human rights and therefore any work focusing on any of the areas of the rule of law is also welcome. Once problems are identified it is vital to propose solutions to guarantee the survival of the EU as we know it. Such a focus can contribute to promoting interdisciplinarity in the EU studies, highlight the interdependence of different socioeconomic, legal, and political dimensions, and facilitate a debate in how to strengthen our European Union.

We invite submissions of individual paper proposals that relate to the broad topic of the **crisis of democratic values in the European Union with preference on those focusing on solutions** rather than identifying the problems. Panels should be in person. **Submissions for contributions are open until 31st of May.**

This Congress is part of the project “Crisis of the Rule of Law in the EU. Special reference to Poland, Hungary, Croatia, Estonia, Spain and Italy and the incidence of the pandemic”, where sixteen researchers from eight universities in more than six different countries have been analyzing the increasingly questioning of the values on which the EU is based and which for decades, we believed to be immovable.

## CALL FOR COMMUNICATIONS: INDIVIDUAL PAPER PROPOSALS

Send your proposal to [ruleoflawcrisiseu@uchceu.es](mailto:ruleoflawcrisiseu@uchceu.es) **before 31<sup>st</sup> of May 2024**. Paper proposals should include a 500-600 word abstract and the name, affiliation, and contact details of the author. Individual papers will be thematically clustered into the following panels. Please, check the panels and select the one more aligned to the topic of your proposal. Applicants will be informed about the acceptance of their submission towards mid of June 2024. We are open to **all methodological approaches (case studies, comparative, theoretical, empirical, statistic, legal...)** and **while those proposing solutions will be preferable, we welcome all type of works related to the values of the European Union, rule of law, democracy...**

Applicants can only submit one paper proposal as main author.

The decision to include the papers in the panels belongs exclusively to the scientific committee.

**NOTE: The organizing body reserves the right to publish some papers with the author's consent.**

**All communications must be in English.**

## THE PANELS

### PANEL 1: Judiciary independence

The panel of judiciary independence welcomes all the works with a more legal perspective both normative and empiric. Separation of powers is one of the foundational elements of our democracies, and attacks on the judiciary even if they look like little, they affect our system. In this panel we expect to create a debate about the importance of the independence of the judiciary and how to protect it and prevent it from further attacks, especially from those coming from the executive.

### PANEL 2: Fight against corruption and transparency

The panel of fight against corruption and transparency aims to explore the relation between corruption and the crisis of democratic values and welcomes works that focus on transparency or specific good practices to overcome corruption.

### PANEL 3: Freedom of speech and media pluralism

In a democratic society is essential to have an informed public opinion. Works on disinformation, misinformation, media pluralism, freedom of speech, protection of journalists, cancellation culture... are welcome here. This panel looks for a comprehensive and interdisciplinary approach on the relationship between media pluralism/freedom of speech and democracy. Also, it welcomes thoughts on how to protect freedom of speech on the internet or social platforms and how to protect EU values in this area.

### PANEL 4: Democracy, Human Rights and institutional issues related to check and balances

Democracy and rule of law cannot be understood without the protection and promotion of human rights and the establishment of adequate check and balances. In this panel we will deepen into the relationship among those four. We welcome any work that questions how the crisis of values is affecting democracy, and what improvements need to be implemented to protect the EU. Topics such as but not limited to populisms, illiberal societies, human rights, integration of immigrants, asylum, might be discussed here.
